Students agreement. PLEASE INITIAL

1. I promise to show up to my sessions on time, with a clear head and all my equipment in hand. I understand that the instructor is not responsible for training me if I am hungover, missing required gear or late. Make up sessions of dives are billable at \$100. 00 per hour (min 2.5hrs) payable to HOLLYWOODIVERS.COM INC only. Instructors are not to collect cash from any student. _____
2. If I forget any required gear and rent it at the dive site, these fees are not covered by Hollywood Divers. It is not the Instructors duty to bring extra gear to the site. _____
3. Hollywood Divers rentals are subject to rinse fees (\$20 per item) and late fees. Please bring your rentals back no later than two days after your class finishes. Bring it back clean. No Sand or Dirt. No Smell. Wet is okay. Thanks. _____
4. Please take precautions against Rental gear theft. If the Rental gear is lost or stolen, I am responsible for gear replacement fees. _____
5. I understand this class is a group class and I should make every effort to be suited up and prepared to dive when the majority of the class agrees to be suited up. _____
6. I understand that weather is unpredictable and the instructor or boat captain has final discretion over diving activities. If conditions are deemed unsafe, it is for your protection and a make up day will need to be scheduled with the group. _____
7. 'Day of' cancellations are subject to a \$100 fee payable to HOLLYWOODIVERS.COM INC only. Instructors are not to collect cash from any student other than gratuity. _____
8. Group make-ups are available in such cases as sickness or injury, for the cost of the rental equipment fee. _____
9. Private make-ups are available for a daily rate of \$350 per ocean day plus the instructors expenses. _____

- Dive lights for night dives (1 primary, 1 backup, 1 tank marker)
- Slate for most classes, Reef ID, Photography, Surveys, Wreck, Navigation
- Reel and Surface Marker Buoy for safety stops, Navigation, Search & Recovery, Wreck.
- Lift bags for Search & Recovery, Wreck.
- Whistle for Rescue, ALL Dives
- Knife for Wreck Dives, all dives
