Industry Associations Join Forces for PASS

After a yearlong effort led by NSCA, the Security Industry Association (SIA), the Consumer Technology Association (CTA), and other industry associations, Congress presented a bill to enact the Power and Security Systems (PASS) Act (S. 190). This bill provides an important provision that is critical to the operation of security and fire alarm systems in regard to federal energy-efficiency requirements.

The PASS Act extends a U.S. Department of Energy policy exempting security and lifesafety external power supplies (EPSs) from having to meet a "no-load mode" energy-efficiency standard, due to the fact these products are always connected and in active mode by

The new law, which took effect on November 2, 2017, removes the July 1, 2017. expiration date on the no-load exemption for security and life-safety products, and authorizes the U.S. Department of Energy to retain this common-sense provision in any future updates to energy-efficiency standards that govern external power supplies.

Without the exemption, security manufacturers would have been forced to redesign power supplies and retool manufacturing processes, increasing production costs by 200 to 300 percent, according to industry estimates.
