



FITTING INSTRUCTIONS FOR BLP0017BK FOOTREST BLANKING PLATE
TRIUMPH DAYTONA 675 2005-



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- 6mm metric Allen key.

FITTING INSTRUCTIONS

- Remove the rear footrest from the rear subframe by un-doing the original nut & bolt.
- Locate the footrest blanking plate in place. The two bosses will locate into the subframe holes.
- Fit two button head bolts with one washer on each bolt through the holes in the subframe from the back side and into the thread of the blanking plate.
- Tighten evenly using 6mm Allen key.

TRIUMPH DAYTONA 675 2005-

Notez que dans les cas où les kits sont emballés avec des rondelles en caoutchouc, composantes du boulon - les rondelles en caoutchouc doivent être jetées !

Outils requis

- Clef Allen 6mm

Instructions de montage

- Enlever le repose-pied arrière du sous cadre arrière en desserrant l'écrou d'origine et le boulon.
- Mettre la Plaque de repose-pieds en place. Les 2 patrons se placeront dans les trous dans le sous-cadre.
- Mettre 2 boulons à tête ronde avec un rondelle sur chaque boulon à travers les trous dans le sous-cadre du côté inférieur et dans le filetage de la plaque repose pied.
- Serrer de façon égale avec une clef Allen de 6mm.

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in re-sellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
