

### **TOOLS REQUIRED**

- Set of metric Allen keys to include 5mm A-F.
  - Allen keys required to remove the footrest.

### Page | 2 FITTING INSTRUCTIONS

- Remove the OEM pillion footrest on the both sides of the motorcycle.
- Place two of the counter-sunk bolts through the holes in one of the blanking plate.
- Offer the R&G blanking plate with bolts into position and tighten into the thread on the sub-frame, as shown above.
- Repeat for the opposite side.


