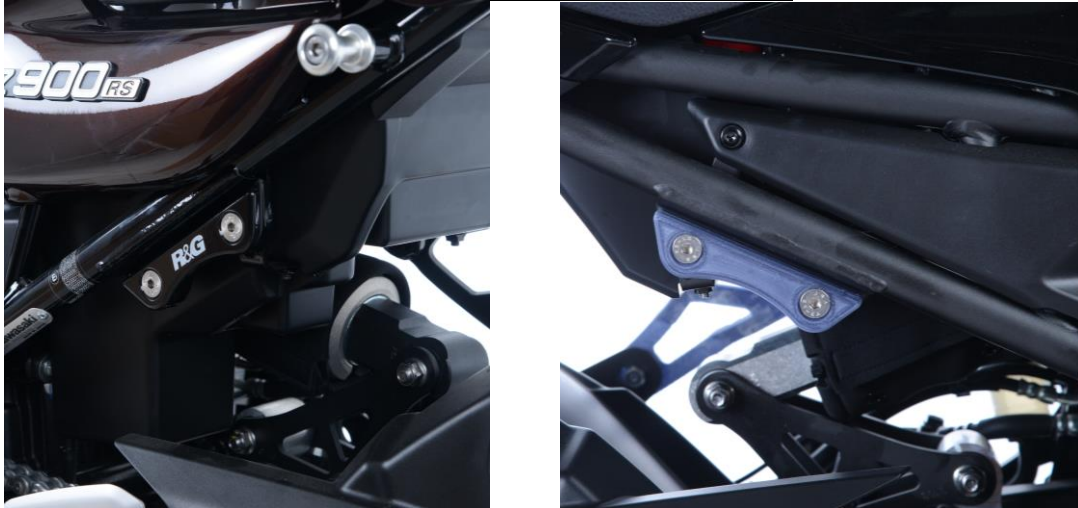

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- Set of Metric Allen Keys.

FITTING INSTRUCTIONS

- Remove the OEM pillion footrests on both sides of the bike.
- Place both counter-sunk bolts through the allocated holes in the blanking plate (**please note on later models the longer counter-sunk bolts will have to be used**).
- Offer the R&G blanking plate into position as shown above and tighten the bolts into the thread on the rear sub-frame.
- Repeat for the opposite side.

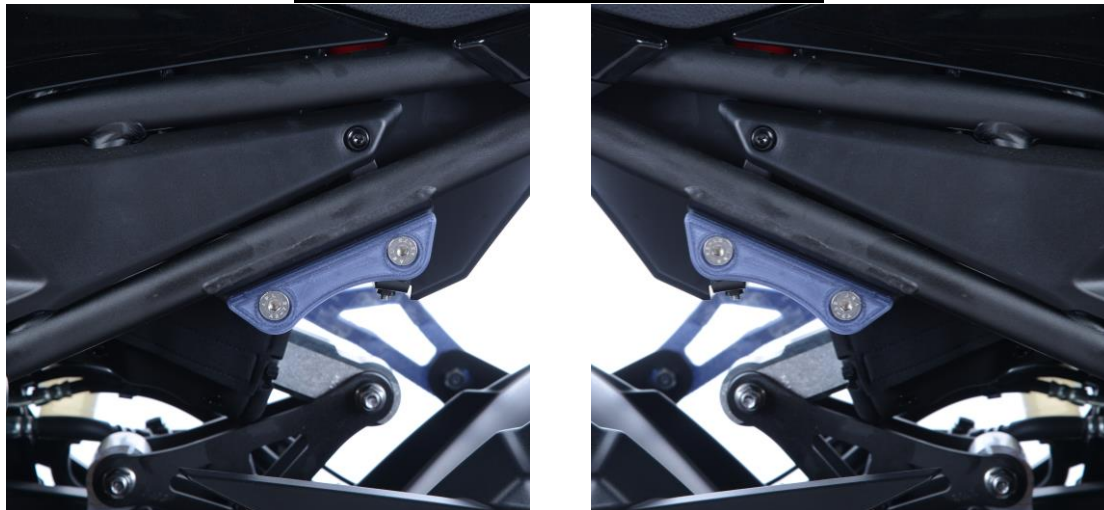

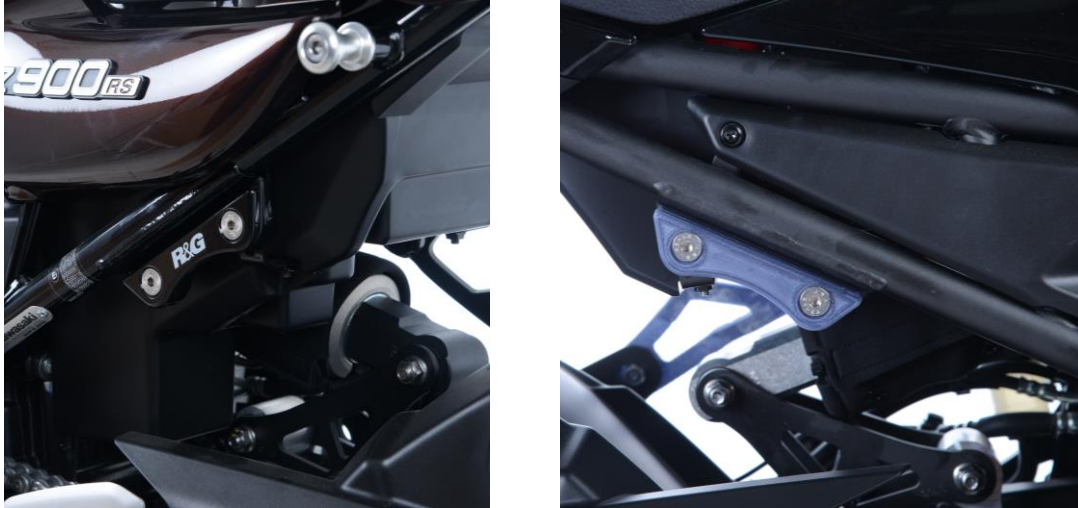
