TOOLS REQUIRED

- 5mm ALLEN KEY

FITTING INSTRUCTIONS

- Remove the two bolts that secure the OEM chainguard in place and remove from the bike.
- Take the R&G Chainguard and offer it into place on the bike the same way as the OEM chainguard was removed.
- Re-fit the OEM bolts through the R&G chainguard and tighten in the threaded bosses on the swingarm.
- Ensure the chainguard is correctly fitted before fully tightening both bolts.
- Please ensure the chain will not hit the chain guard in operation.
