


FITTING INSTRUCTIONS FOR CP0225BL CRASH PROTECTORS YAMAHA FZ1-S (1000 FAZER) 2007 WITH LOWER FAIRING (OEM)



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

Left-hand side (as you sit on bike)

- Remove engine bolt shown arrowed on top right hand photo.
- Leave OEM spacer in frame recess.
- Take one M10x1.25x140mm long hex head bolts and slide one of the M10 washers to head of bolt.
- Place the bolt and washer through the bobbin and then slide one of the stepped spacers over the bolt thread and up to the bobbin (larger diameter goes against bobbin neck).
- Fit bobbin assembly to the bike (through fairing support bracket and OEM spacer) as shown above right. PLEASE NOTE BOBBIN MUST BE POSITIONED AS PICTURED ABOVE WITH BIGGER END TOWARD FRONT OF BIKE.
- Using torque wrench and 17mm socket, tighten bolt until you feel some compression from inside the protector. Turn a little more so that you feel the compression increase slightly. Then apply a quarter turn. Do not overtighten as damage can occur to the bike. Do not exceed 40nm of torque.



Right-hand side (as you sit on bike)

- Remove engine bolt shown arrowed on top left hand photo.
- Leave OEM spacer in frame recess.
- Take one M10x1.25x140mm long hex head bolts and slide one of the M10 washers to head of bolt.
- Place the bolt and washer through the bobbin and then slide one of the stepped spacers over the bolt thread and up to the bobbin (larger diameter goes against bobbin neck).
- Fit bobbin assembly to the bike (through fairing support bracket and OEM spacer) as shown above right. PLEASE NOTE BOBBIN MUST BE POSITIONED AS PICTURED ABOVE WITH BIGGER END TOWARD FRONT OF BIKE.
- Using torque wrench and 17mm socket, tighten bolt until you feel some compression from inside the protector. Turn a little more so that you feel the compression increase slightly. Then apply a quarter turn. Do not overtighten as damage can occur to the bike. Do not exceed 40nm of torque.

These terms do not affect the Buyer's statutory rights.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.
