General Description: Individually wrapped solid scrub for Hand/Feet/Body.

2. **COMPOSITION**

Sodium chloride (fine grain salt), Sucrose (pure cane sugar), Theobroma Cacao (Cocoa) Seed Butter, Butyrospermum parkii (Shea Butter) Fruit, Persea Gratissima Oil and Hydrogenated Vegetable Oil (Avocado Butter), Persea Gratissima (Avocado) Oil, Macadamia Ternifolia (Macadamia Nut) Seed Oil, Prunus Amygdalus Dulcis (Sweet Almond) Oil, Tocopherol Acetate (Gluten Free Vitamin E), Fragrance, Colorant (may contain one or more of the following: Brown Iron Oxide, Yellow 6 Lake, Yellow 5 Lake, Blue 1 Lake, Mica, Green Oxide, Polyester-3, Manganese Violet).

All ingredients are approved by The Personal Care Products Council (Formerly CTFA) standards and US Food, Drug & Cosmetic Act as safe for personal care products. All of our fragrance use is within the IFRA recommended usage level.

3. **HAZARD IDENTIFICATION**

Non-hazardous: Generally recognized as safe. No chronic effect known or expected.

Medical conditions aggravated by exposure: Allergy to one or more ingredients.

Toxicity: Non-toxic
