Dealer Sales Representative Incentive Terms & Conditions

These Terms and Conditions form the basis on which Participants may be eligible to participate in the Promotion. By participating in the Promotion (including by submitting an Eligible Quote in accordance with these Terms and Conditions), Accredited Dealers and Participants are deemed to have read, accepted and agreed to be bound by these Terms and Conditions and any participation in the Promotion by Accredited Dealers and Participants constitutes an irrevocable agreement to these Terms and Conditions.
