Mission Creek provides secure, online access to payment information 24-hours a day, free of charge, through EnergyLink. To access the site, you may go to <https://www.energylink.com/>. **Your login information will be provided in a separate mailing that will coincide upon your receipt of your first revenue disbursement.**

*Note: If you have an existing EnergyLink account, you may need to contact EnergyLink to have disbursements from Mission Creek mapped to your EnergyLink account. Their contact information can be found at the following website: <https://www.energylink.com/Contact>.*

Please note that Mission Creek's minimum release of revenue is \$50.00; amounts less than \$50.00 will be held in suspense until it meets or exceeds the \$50.00 amount.

Mission Creek is very pleased to offer ACH Direct Deposit for you to receive your royalty payments electronically. Please complete the enclosed form to enroll and allow at least 90 days to process your request. **During this 90-day processing period, you will continue receive paper checks.** Please be aware that ACH direct deposit is preferred but voluntary; **if you would like to receive your disbursement in the mail, you do not need to do anything further.**
