

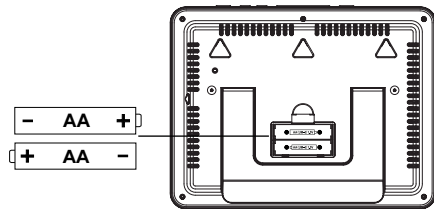

STEP 1: POWER UP

Hold the MODE button to enter set mode. Use +/- buttons to adjust and MODE to confirm.

OTHER BUTTON FUNCTIONS

- **Press MODE:** Select between Calendar, Indoor Temperature, Seconds, Full Weekday, or Date
- **Hold ALARM:** Set alarm time. Use +/- buttons to adjust and ALARM to confirm.
- **Press SNOOZE:** Silence alarm for 10 minutes.
- **Hold then press ALARM:** to activate/deactivate time alarm.
