Off Licence (For Premises)

Sections 17 to 20, 40 (remote sales) and 64, Sale and Supply of Alcohol Act 2012

PURSUANT to the Sale and Supply of Alcohol Act 2012, **Gails Floral Studio Limited** is authorised to sell alcohol from the premises situated at Worley Place Hamilton Central Hamilton 3204 and known as "**Gails Floral Studio**", to any person for consumption off the premises.

Endorsement: Section 40 of the Act applies to this licence; and the licensee is authorised to sell alcohol from (but not on) the premises and deliver it somewhere else. The off-licence is endorsed for the remote sale of alcohol by using a Remote Sales Premises.

CONDITIONS: This Licence is subject to the following conditions:

- (a) Alcohol will only be sold as part of a gift basket/hamper that contains other non-alcoholic products (no alcohol only sales).
- (b) Gift baskets/hampers containing alcohol may be sold at any time, on any day, while always trading as a remote seller.
- (c) Gift baskets/hampers containing alcohol must not be delivered on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day, or between 11:00pm and 6:00am the following day.
- (d) The licensed premises is described in the plan date stamped as received by the Hamilton District Licensing Committee on 29 September 2022.
- (e) The licensee must take reasonable steps to verify that the buyer and the receiver of an alcohol delivery is not under 18 years of age, and that the receiver is not intoxicated.
- (f) The outside of the delivery package must contain a label with the following words:
 - CONTAINS ALCOHOL
 - Do not leave at destination without proof of delivery.
 - Do not deliver to intoxicated persons or persons under 18 years of age (and person appearing to be 25 years or under must provide valid ID.
- (g) A copy of the licence must be displayed on the www.gails.co.nz internet site in a prominent place.
- (h) Every receipt for the sale of alcohol by remote sale must contain the licence holder's name, licence number and the date on which the licence expires.
