This Luna Bean Awards Content Submission Agreement (the "Agreement") is a binding agreement between you ("You") and Luna Bean, LLC, a Florida limited liability company ("Luna Bean").

#### **Luna Bean Social Media Contest - Terms and Conditions**

#### 1. General Information

- The Luna Bean #LunaBeanStoryContest Social Media Contest ("Contest") is organized by Luna Bean ("Organizer").
- By entering the Contest, participants agree to be bound by these Terms and Conditions.

# 2. Eligibility

#### 5. Submission Guidelines

- All submissions must:
  - o Be original and created by the participant.
  - o Not contain any inappropriate, offensive, or illegal content.
  - o Not include copyrighted material, including music, logos, or images, unless the participant owns the rights or has explicit permission.

### 6. Selection of Winners

- Submissions will be judged based on the following criteria:

 The Organizer reserves the right to amend these Terms and Conditions at any time without prior notice. Any changes will be communicated via the official contest landing page on Luna Bean's website.

In the event of any inconsistency or conflict between the terms and conditions of the TOU or Privacy Policy and this Agreement, the terms and conditions of this Agreement shall prevail.

NOW, THEREFORE, for good and valuable consideration, the sufficiency of which is acknowledged, the parties agree as follows:

LICENSE GRANT. Submitting UGC means that You hereby grant to Luna Bean, with a right to sublicense for commercial use, a perpetual, worldwide, unlimited, irrevocable, transferable, assignable, royalty-free, fully-paid license for Luna Bean to use that UGC and Your Appearances or other identifying information in connection with Your UGC, and the right to record, copy, publicly perform, broadcast, exhibit, transmit, distribute create derivate works and otherwise exploit any master recordings and

  - Home Video / EST: All home video formats (i.e., DVD, Blu-Ray, VHS and other fixed, transportable audiovisual media) and the "electronic sell-through" of motion pictures and television programs embodying the Content in digital download formats;
  - o Internal Usage: internal usage for testing and system improvements by Luna Bean

- Other Uses: Any other exhibition, display, performance, communication to the public, distribution, exploitation or other use of the Content and/or Appearances not set forth above.
- **(b)** to the extent that You or any third party recognizably appear in the Content, to use the Appearances, in or in connection with the Content, in any and all media now known or hereafter created, including, but not limited, for the Licensed Uses for any purpose and as necessary to exercise the rights granted in these Terms. Subject to applicable laws, You waive any moral and privacy rights that You or Your licensors may have in any UGC.

**USE OF YOUR UGC.** Submission of Content to Luna Bean is not a guarantee that Luna Bean will publish or otherwise use the Content. For clarity, as part of the Licensed Uses, Luna Bean may use Your Content, in whole or in part or as part of the Luna Bean Materials without any further approval by You.

**OWNERSHIP**. Luna Bean acknowledges and agrees that You retain all right, title and interest in and to the UGC and Appearances, including all intellectual property rights, rights of publicity or privacy and moral rights therein, other than those rights granted herein. You acknowledge and agree that Luna Bean shall acquire all right, title and interest in the derivative works of the UGC that are contained as part of the Luna Bean Network Materials.

**PAYMENT TERMS**. Potential Recipients of Luna Bean Award will be notified through the Luna Bean Awards portal by E-mail (via the E-mail account used to sign in to Luna Bean Awards) and will be required to respond (as directed) to the notification attempt. Potential Recipients will be required complete personal information, payment method and required forms to comply with tax reporting obligations to receive their Award. If a Potential Recipient cannot be contacted by email after three (3) attempts over a 30-day period, or if they fail to correctly complete any of the required documentation for payment, the Potential Recipient will forfeit their Award.

#### ALTERNATIVE ENTRY METHOD.

- Submission Format:
  - Create and submit a video that aligns with the contest theme (e.g., storytelling, creativity, emotional impact). The video does not need to feature a Luna Bean product but must still meet the contest's general guidelines and criteria.
  - Participant may enter by mailing a video submission to GOJA, 8400 NW 36th St # 500, Doral, FL 33166, including their name, contact information, and response to the contest prompts.
- o Deadlines:

 For online submissions, entries must be uploaded by 11:59 PM EST on the last day of the contest month. Submission will be entered in contest based on month video received.

## Judging:

• Videos submitted via the alternative entry method will be judged using the same criteria and scoring process as all other entries to ensure fairness.

WARRANTIES. You represent and warrant that: (i) You have all rights and licenses necessary to grant to Luna Bean the rights granted in the UGC and Appearances, including but not limited to rights to synchronize any master recording and or composition used to video, images, video, audio, photos, text, or other material embedded within the UGC, and You will pay any and all third parties who may be entitled to a royalty or fee (including public performance organizations) arising from the Licensed Use of any composition or master recording embedded within the UGC; (ii) to the extent any Third-Parties are visible in the UGC, You have obtained express consent from the Third-Parties to submit their likeness; (iii) Luna Bean's use or sublicense of the UGC, Appearances, or Third-Party Materials as contemplated by this Agreement will not infringe, misappropriate or violate a third party's intellectual property rights, rights of publicity or privacy, moral rights or any applicable law or regulation; (iv) Your agreement to the terms and conditions of this Agreement will not violate or conflict with any obligations owed by You to a third party; and (v) you will comply with all laws, rules and regulations applicable to this Agreement.

**INDEMNITY**. You will indemnify, defend and hold Luna Bean harmless from and against any and all claims, demands, damages, liabilities, losses, costs and expenses (including reasonable attorneys' fees) arising from or related to: (a) breach of any of Your representations and warranties in this Agreement; (b) any third party claim that the UGC or Appearances, or Luna Bean's use thereof, infringe, misappropriate or violate such third party's intellectual property or other third party rights and (c) any third party claim that is based on any act or omission of You that results in personal injury, death, property damage or the violation of any law, ordinance or regulation.

LIMITATION OF LIABILITY. The parties to this Agreement are independent contractors and this Agreement will not establish any relationship of partnership, joint venture, employment, or agency between the parties.
