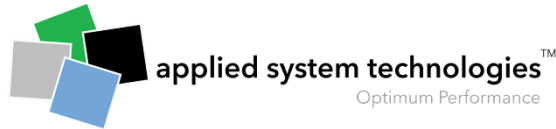

Limited Lifetime Warranty

This Limited Lifetime Warranty is effective as of January 1, 2018 (the “Effective Date”). The warranted products include all Applied System Technologies (“AST”) **Infinity™ and Elevation™** products sold by AST after the Effective Date, excepting only fittings with movable parts such as butterfly valves (all such warranted products being referenced hereafter as the “Lifetime Products”). Subject to the terms and conditions of this Limited Lifetime Warranty, the Lifetime Products are warranted to be free from any material defects in manufacture and to conform to any industry standards in effect at the time of manufacture and referenced by AST in the applicable product written documentation (the “Published Standards”), in each case **for the life of such Lifetime Products from the date of delivery** (the “Lifetime Warranty”).

AST’s sole liability and purchaser’s sole remedy for breach of the Lifetime Warranty is limited to replacement (and not removal or reinstallation) of any such defective Lifetime Product that is returned to AST at the address set forth below by the original purchaser of the Lifetime Product from AST or any AST reseller or distributor. In the event that the original Lifetime Product is no longer manufactured by AST with equivalent specifications, a replacement product substitutable for such Lifetime Product may be selected by AST in its reasonable discretion. If AST discontinues the Lifetime Product and no substitutable replacement product is available, AST may credit the purchaser with an amount equal to the original purchase price of the Lifetime Product. In no event shall AST be liable for any other obligations with respect to any defective Lifetime Products, including, without limitation, any refund of the amount paid for such defective Lifetime Products, notwithstanding the failure of the essential purpose of the Lifetime Warranty set forth herein. **THIS LIMITED WARRANTY IS THE ONLY WARRANTY MADE BY AST AND IS EXPRESSLY IN LIEU OF ALL OTHER WARRANTIES, EXPRESS AND IMPLIED, INCLUDING ANY WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WHICH ARE HEREBY DISCLAIMED BY AST.**

This Limited Warranty will not apply if:

- 1) The Lifetime Products are not properly installed in good and workman-like manner consistent with prevailing industry practices and in conformance with the latest instructions published by AST (the “AST Documentation”), the Published Standards, and all applicable plumbing, fire and building codes (“Applicable Codes”).
- 2) The Lifetime Products are used for any purpose other than their intended purpose as limited by the AST Documentation, Published Standards, and Applicable Codes.
- 3) The Lifetime Products are used in systems or with products that are: (a) defective or not adequately designed, manufactured, engineered, or installed; (b) not demonstrated to meet the Published Standards and Applicable Codes (unmarked products shall be deemed to not meet the Published Standards or the Applicable Codes), (c) are not compatible with the Lifetime Products
- 4) The Lifetime Products have been the subject of modification, misuse, uninstallation and reuse, refurbishment, misapplication, improper maintenance or repair, damage caused by the fault or negligence of anyone other than AST, or any other act or event beyond the control of AST.

Purchaser must obtain a return materials authorization and instructions for return shipment to AST for any Lifetime Warranty claim. Any Lifetime Products alleged to be defective must be made available to AST at the following address for verification, inspection and determination of cause:

No statement, conduct or description by AST or its representative, in addition to or beyond this Limited Warranty, shall constitute a warranty. This Limited Warranty may only be modified in writing signed by an officer of AST.
