




#### **SET UP INSTRUCTIONS**

Thera 3 is the easiest device to set up. After you take it out of the box.

- 1. Find and connect power plug into the power port (left side).
- 2. Plug the cord into the power port on the left side of the device.
- 3. Plug the bubbler hose and air stones into the ozone output port on the right side of the device.

- 6. Now your TheraO3 is fully ready to begin using and enjoying the device.






### **OZONE OPERATING INSTRUCTIONS**

#### EASY TO USE OPERATING INSTRUCTIONS

Now that your device is fully set up let's find the  $\bigcirc$ 3 power button and press to power device  $\bigcirc$ 0n.

- 1. Click the selection on left of ON/OFF to advance selection 1-5 that serves you. Click the selection on right of ON/OFF to reverse selection 1-5 that serves you. Manual adjustment or use Remote (in certain models)
- 2. When the session times out the Bubbler will stay on and cycle thru the finish cycle for approximately 30 seconds before turning off.



## OZONE APPLICATION INSTRUCTIONS

#### EASY TO USE HOME OPERATING INSTRUCTIONS

Settings / Applications	Function & Effects
1. Preserve Freshness (5 min.)	
Fish & Meat Washing	Kills the bacteria on meat and fish
Food Preservation	Extend the freshness of fruits & vegetables, disinfects foods
2. Kills Bacteria (10min.)	
Fruit and Vegetable Washing	Dissolves and eliminates pesticides, kills bacteria on surfaces of food
3. Sterilization (15 min.)	
Washing utensils	Kills the bacteria on utensils, surfaces, disinfects bottles & toys

#### **PRECAUTIONS**

#### Caution

- Ozone resting at room temperature for approximately 15 minutes, will revert back to oxygen, and therefore will loose some of its' potency and effectiveness;
- Ozone concentration of this device is in a safe breathable range, When using for sanitation or for sterilization of small rooms and small objects the device operates best when it is standing alone and bubbled thru hydration cup;
- When cleaning a closed room or to improve efficiency, close all windows or areas that air can easily flow out. After the session or sterilization is completed, it recommended to allow 20 minutes of fresh flowing air in the space where the device was utilized. Take extra caution when using in a small enclosed space (such as car / or small room) open a small door / window to allow ozone to escape and fresh air to come in. Individuals should consult with their Professional Health Provider to get further information and applied health science for best results and any or all limitations of use based on the individuals health condition.

#### 1. WHAT THIS LIMITED WARRANTY COVERS AND HOW LONG

This Product includes the product itself, and, unless specifically excluded below, all material, parts, and components related to functionality. This Limited Warranty applies only when all of these parts are genuine Therasage components. Cosmetic components are not covered by this Limited Warranty.

- a) COVERAGE Subject to the limitations and exclusions below, and for the duration of the applicable Warranty Period, Therasage, and any of its affiliates, ("Seller") warrants that the Product's components will be free from material and functional non-conformities in material and workmanship under normal and reasonable consumer conditions.
- b) WARRANTY PERIOD For the one year period of this Warranty, Therasage, at its discretion, will repair or replace any defective part, component, mechanism, or material. This warranty coverage shall include all defective parts, but shall exclude all labor charges. The Warranty Period shall commence upon purchase of the product by the end-user consumer from an authorized dealer.
