

Liability Waiver and Release

This document may have legal consequences: you must read and sign it carefully.

In consideration for my being permitted access to the premises and property located at 39001 Highway 93, Stevensville, Montana and or participate in the activities of archery I agree to the following waiver and release of Straight 6 Archery:

I agree that the activities involved in archery have inherent risks, hazards, and dangers for anyone, which cannot be eliminated. I UNDERSTAND THAT THESE RISKS, HAZARDS AND DANGERS INCLUDE BUT ARE NOT LIMITED TO:

Risk of handling archery equipment, and being near others that have archery equipment and arrows in their possession, risk of injury from handling and shooting archery equipment and the removal of arrows from targets, ricochets, equipment failure, inclement weather conditions, puncture and cut injuries, damage to property by others or flying debris or projectiles.

In Exchange for access to the premises, I agree:

- 1) I assume sole responsibility for:
 - a) My actions and the actions of those under my control, if a guest or minor accompanies me and supervision in the use of archery equipment and vehicles and/or any other personal property while on the premises, and all such actions or conduct shall not be attributable in any manner to Straight 6 Archery, its agents or assigns; -
 - b) any loss or injury which maybe directly or indirectly attributable to my acts while on the property; and I agree to indemnify Straight 6 Archery for any monetary damages which may be assessed against me as a result of my actions or activities.
- 2) Each member/guest is familiar with and knowledgeable concerning any and all personal property used on the property. Further, each member/guest affirms that he/she will comply immediately with instruction from range safety personnel present on the facility. Further, each member affirms that he/she will be responsible for the actions of their guest(s) while on the property.
- 3) The member/guest hereby releases forever Straight 6 Archery, its officers, directors and range safety personnel, jointly and severally, of any liability for the actions of the member/guest in their use of the facility, and waives any claim the member/guest believes he/she now has or hereafter may acquire against Straight 6 Archery, its successors and/or assigns.
- 4) If the guest is a minor, or under any disability which prevents the said guest from acting in their own interests, then their participation in any activity while on the premises shall be under the

supervision of a parent or other legally designated guardian; or if the activity is under the sponsorship of a Club or other officially sanctioned youth or disability program, then such participation shall be under the supervision of a designated supervisor of such program or activity, which shall be solely responsible for their action.

- 5) Straight 6 Archery reserves the right to refuse any person the use of the Club property in accordance with the following polices:
 - a) Any guest may be refused permission to use the property for any reason or for no reason, in the sole discretion of Straight 6 Archery, its officers, directors or in the judgment of any range safety personnel present on the facility.
 - b) NO ALCOHOL. Consumption of alcohol before using or while on Straight 6 Archery property is strictly prohibited. Anyone suspected of consumption of alcohol before or while at the premises shall be prohibited from the premises.
- 6) The member/guest acknowledges that he/she has read and understands the foregoing, and executes this release and waiver of his /her own free will and not under any form of coercion or duress; a copy of the form has been received by the member/guest.
- 7) I certify that I have adequate insurance to cover any injury or damage I may cause or suffer while participating in any activity at the Range, and/or using archery equipment. I further certify that I am willing to assume the risk of any medical or physical condition I may have.
- 8) I understand all the risks I am voluntarily assuming and have had the opportunity to discuss them with Straight 6 personnel. I understand I have responsibilities to safety and my participation is purely voluntary and I accept any and all risk of injury or death.
