


### FITTING INSTRUCTIONS FOR BCG0001BK BRAKE CALIPER GUARD SINNIS APACHE SMR 125 '17-



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike.

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

### **TOOLS REQUIRED**

- 10mm socket & wrench.
  - 4mm A/F Allen key.

### **FITTING INSTRUCTIONS**

- Remove the two bolts that mount the OEM guard in place, as shown in picture 1.
- Remove the OEM guard, as shown in picture 2.
- Place one washer onto each of the two bolts supplied and then position the bolts through both holes on the R&G caliper guard, as shown in the exploded diagram.
- Place one spacer onto the exposed end of both bolts, as shown in picture 3.
- Offer this assembly up to the bike, locating the bolts through the mounting holes of the brake and tighten into the threaded bosses, as shown in picture 4.
- Ensure all bolts are fully tightened and the rear brake is securely fixed in place and working before riding.



- Enlever la protection d'origine, voir photo 2.
- Placer une rondelle sur chacun des boulons fournis puis positionner les boulons dans les 2 trous de la protection d'étrier R&G, voir le schéma.
- Placer une entretoise sur l'extrémité des 2 boulons, voir photo 3.
- Monter l'ensemble sur la moto, en plaçant les boulons dans les trous de fixation du frein puis serrer dans les trous filetés, voir photo 4.
- Veiller à ce que tous les boulons soient complètement engagés et que le frein arrière soit fixé en position et fonctionne correctement avant de prendre la route.
