

FITTING INSTRUCTIONS

- Remove the two bolts that secure the OEM pillion footrests in place on both sides of the bike. The footrest hangers should now come away from the bike.
- Fit two bolts (**Item 2**) through either blanking plate (**Item 1**) and offer up to the bike and tighten.
- Repeat the above process to fit the blanking plate to the other side of the bike.
- Ensure bolts are torqued correctly using the (GENERAL TUORQUE SETTINGS) table on page
 2.




