

## **FITTING INSTRUCTIONS**

- 1) Remove the plastic OEM chain guard by removing the three bolts shown in Picture 1 & 2.
- 2) Using the three OEM bolts (in the same positions they were removed from), thread them through the chain guard and into the mounting lugs on the swingarm one by one.

It is recommended to use a thread locking compound at this stage.

3) Tighten all three to the correct torque settings using the OEM torque settings for the bolts used.

**Please note:** Remember to check the torque setting when performing routine maintenance (cleaning/servicing chain).
