

# **TOOLS REQUIRED**

- Set of Allen keys to include 4mm A/F.
- T30 Torx bit.

#### FITTING INSTRUCTIONS

- To fit the Lever Guard (item 3) remove the original bar end and remove the rubber expander for reuse.
- Place the counter-sunk bolt (item 1) through domed counter-sunk spacer (item 2) and then through the Lever Guard so the domed spacer sits against fixed spacer in the Lever Guard.
- Place the large cone spacer (item 4) over the thread and into the Lever Guard.
- Place the large spacer (item 5) over the thread and against the cone spacer as shown above.
- Place the original rubber expander onto the thread so it sits against the spacer just fitted.
- Locate the assembly into the bar and position so when the motorcycle is at full lock in both directions it does not contact any other part of the motorcycle.
- Fully tighten the bolt and check operation.




