

FITTING INSTRUCTIONS

- Pre-assemble the kit as shown in **COMPONENTS PARTS DIAGRAM**, secure to the bike using the M10 bolt and S0036 spacer.
- Repeat this for both sides of the bike.
- Check the bolt frequently and if necessary please apply a small amount of thread locker.


