



FITTING INSTRUCTIONS FOR R&G EXHAUST PROTECTOR EP0020BK



- The R&G can cover is designed to fit in your preferred position on the exhaust muffler.
- Open the jubilee clip completely, so that it is no longer continuous.
- Place black “rubber” strip around the can, in the position intended for the jubilee clip of the can cover.
- Cut the strip to size.
- Locate the jubilee clip around the strip.
- Check that the position of the can cover is as required. Re-tighten the jubilee clip in order to secure the can cover.
- While the jubilee clip is tight mark position where the excess jubilee clip meets the protector.
- Remove or loosen the jubilee clip and cut excess off approx 8mm from mark (using hack-saw or good quality tin-snips), this will allow the 8mm to be tucked between the jubilee clip and the silicon mounting strip to keep things neat, safe and tidy.

Please note that it is your responsibility to ensure that no part of the exhaust protector assembly fouls or comes into contact with other parts of the machine. Do not ride the motorcycle until this aspect has been verified and you have compressed the rear suspension (if appropriate to the design of the motorcycle) to test this thoroughly.

NOTICE DE MONTAGE POUR PROTECTION D'ÉCHAPPEMENT R&G EP0020BK



- La protection pot d'échappement est conçue pour être installée dans la position qu'il vous plait sur votre silencieux.
- Ouvrez complètement le collier de serrage, de sorte à ce qu'il ne continue plus
- Placez le caoutchouc noir autour de la boîte, dans la position prévue pour le collier de serrage
- Ajuster la taille de la bande.
- Placer le collier de serrage autour de la bande.
- Vérifier que la protection d'échappement soit correctement placée. Resserrez le collier de serrage afin d'assurer le serrage de la protection.
- While the jubilee clip is tight mark position where the excess jubilee clip meets the protector.
- Enlever ou desserrer le collier de serrage et couper l'excès de 8mm environ de la marque (à l'aide d'une scie à métaux ou d'étaim-cisailles de bonne qualité), cela permettra à la longueur de 8mm d'être coincée entre le collier de serrage et la bande de silicone de montage pour garder une installation propre, sûre et ordonnée.

Il est de votre responsabilité de vous assurer qu'aucune partie de l'ensemble support de pot d'échappement n'entre en contact avec une autre partie de la moto. Ne pas prendre la route sans avoir fait ces vérifications. Compresser l'amortisseur arrière pour jauger de cet aspect par exemple (si le design de la moto le permet).
