

FITTING INSTRUCTIONS FOR R&G EXHAUST PROTECTOR EP0028BK



- The R&G exhaust protector is designed to fit in your preferred position on the exhaust muffler.
- Open the jubilee clip completely, so that it is no longer continuous.
- Place black "rubber" strip around the can, in the position intended for the jubilee clip of the can cover.
- Cut the strip to size.
- Locate the jubilee clip around the strip.
- Check that the position of the can cover is as required. Re-tighten the jubilee clip in order to secure the can cover.
- While the jubilee clip is tight mark position where the excess jubilee clip meets the protector.
- Remove or loosen the jubilee clip and cut excess off approx 8mm from mark (using hack-saw or good quality tin-snips), this will allow the 8mm to be tucked between the jubilee clip and the silicon mounting strip to keep things neat, safe and tidy.

Please note that it is your responsibility to ensure that no part of the exhaust protector assembly fouls or comes into contact with other parts of the machine. Do not ride the motorcycle until this aspect has been verified and you have compressed the rear suspension (if appropriate to the design of the motorcycle) to test this thoroughly.

INSTRUCTIONS DE MONTAGE R&G PROTECTION ECHAPPEMENT EP0028BK



- La protection R&G est conçue pour être montée dans votre position préférée sur le silencieux d'échappement.
- Ouvrez le clip du jubilé complètement, de sorte à ce qu'il ne soit plus continu.
- Placer le caoutchouc autour du silencieux, dans la position prévue pour le clip de la protection échappement.
- Couper le bandeau à la bonne taille.
- Placer le clip du jubilé autour du bandeau.
- Vérifier que la position de l'échappement est correcte. Resserrer le clip de jubilé pour fixer la protection du silencieux.
- Pendant que le clip de jubilé est serré, marquer la position où l'excès de clip de jubilé touche la protection.
- Enlever ou desserrer le clip de jubilé et couper l'excès à approximativement 8mm de la marque (en utilisant une scie à métaux ou une cisaille de bonne qualité), cela permettra aux 8mm de se nicher entre le clip de jubilé et le bandeau de silicone pour garder les éléments de façon rangée, propre et serrée.

Il est de votre responsabilité de vous assurer qu'aucune partie de l'ensemble support de pot d'échappement n'entre en contact avec une autre partie de la moto. Ne pas prendre la route sans avoir fait ces vérifications. Compresser l'amortisseur arrière pour jauger de cet aspect par exemple (si le design de la moto le permet).
