


FITTING INSTRUCTIONS FOR ES0005 EXHAUST SLIDER BMW C650GT 2012-



THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike.

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)





LEGEND

 $\overline{\text{ITEM 1} = \text{SLIDER (SL0008) (x1)}}$.

ITEM 2 = M6x25mm LONG COUNTERSUNK BOLTS (x2).

ITEM 3 = MOUNTING PLATE (MP0021) (x1).

ITEM 4 = SPACER (S0456) (x1).

ITEM 5 = M5x15mm LONG COUNTERSUNK BOLTS (x2).

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away*!

TOOLS REQUIRED

- Set of metric Allen keys to include 3 & 4mm A/F sizes.
 - 10mm Socket and wrench.
 - Set of Torx bits.

FITTING INSTRUCTIONS

- Remove the two bolts that secure the plastic cover onto the side of the exhaust silencer.
- Take the mounting plate (item 3) and insert the M6 x 25mm long countersunk bolts through each hole. Offer up to the exhaust cover, ensuring that the spacer sits between the plastic cover and the mounting plate on the bolt nearest the front of the scooter. Tighten both bolts evenly.
- Fit the slider (item 1) to the mounting plate by inserting the two M5 x 15mm long countersunk bolts through the slider and into the mounting plate, before tightening evenly.



ARTICLE 1 = Slider (SL0008) (x1).

ARTICLE 2 = M6x25mm Boulons fraisés (x2).

ARTICLE 3 = Support de plaque (MP0021) (x1).

ARTICLE 4 = Entretoise (S0456) (x1).

ARTICLE 5 = M5x15mm Boulons fraisés (x2).

Notez que si les kits sont emballés avec des rondelles en caoutchouc servant à tenir les composants, ces rondelles doivent être jetées.

Outils requis

- Clés Allen 3 & 4mm
 - Clé 10mm
 - Clé Torx

Instructions de montage:

- Enlever les 2 boulons qui fixent le couvercle en plastique du coté du silencieux.
- Prendre la plaque de montage (Article 3) et insérer les boulons à tête fraisée M6 x 25mm dans chaque trou. Poser la protection pot d'échappement, en vous assurant que l'entretoise aille entre la protection en plastique et la plaque de montage sur le boulon le plus proche de l'avant du scooter. Bloquer les boulons de façon égale.
- Installer le slider (Article 1) à la plaque de montage en insérant les 2 boulons à tête fraisée
 M5 x 15mm à travers le slider et dans la plaque de montage, avant de fixer tous les boulons de façon égale.
