

TOOLS REQUIRED

• 4mm A/F Allen Key or socket & wrench.

FITTING INSTRUCTIONS

- Fit one bolt and washer through either frame insert (FI0061) and then fit one slotted spacer (S0818) over he exposed end of the thread, with the open end of the spacer facing outward.
- Fit one of the tapered nuts to the exposed thread so that the tapered section tightens into the slotted opening on the back of the spacer.
- Tighten this so that it is finger tight before inserting into the frame/swingarm pivot boss on the bike
- Tighten the bolt so that the spacer expands and grips the inside of the swingarm spindle.
- Repeat this to fit the frame insert on the other side of the bike.
- Fit the bubble stickers into the recess on both frame inserts.



Clé Allen 4mm.

INSTRUCTIONS DE MONTAGE

- Passer un boulon et une rondelle à travers l'insert de cadre (FI0061) et placer une entretoise (S0818) sur l'extrémité du filetage, avec l'extrémité ouverte de l'entretoise vers l'extérieur.
- Insérer un des écrous sur le filetage exposé de façon à ce que la section crantée se fixe dans la fente à l'arrière de l'entretoise.
- Serrer avant d'insérer dans le patron pivot de cadre/ bras oscillant sur la moto.
- Serrer le boulon pour que l'entretoise prenne le grip dans le moyeu de bras oscillant.
- Répéter cela pour installer l'insert de cadre de l'autre coté de la moto.
- Placer les stickers de coutchouc dans le creux des 2 inserts de cadre.
