**MV AGUSTA F3 675/800 '12-, BRUTALE 675/800 '12- & RIVALE 800 '14-**  
**LOWER LEFT CAST SECTION**



**THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW.**  
**DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.**

**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

**TOOLS REQUIRED**

- 3mm metric Allen key.

**FITTING INSTRUCTIONS**

- Fit button head bolt through frame insert so head sits in counter-bore.
- Place special nut on exposed end of bolt so tapered face goes into tapered slot.
- Tighten bolt until tapered portion of nut just contacts tapered face of plastic frame insert.
- Place the assembly into frame recess in position shown above with recess horizontal as shown above.
- Tighten bolt so frame insert is held in position firmly (do not over tighten).
- Push fit cap in centre as shown above.
- Regularly check to ensure frame insert remains tight.

- Passer le boulon à travers l'insert de cadre de façon à ce que la tête soit placée dans le contre alésage.
- Placer l'écrou spécial sur l'extrémité du boulon de façon à ce que la face conique aille dans le support conique.
- Serrer le boulon jusqu'à ce que la partie conique de l'écrou soit en contact avec la face conique de l'insert de cadre.
