



Upper left hand side (as you sit on bike)

ENSURING THE LOGO IS IN THE CORRECT ORIENTATION PLACE THE FRAME INSERT INTO FRAME RECESS AND GENTLY KNOCK IN WITH A SOFT MALLET OR THE PALM OF YOUR HAND.


