MV AGUSTA BRUTALE 1090 2013-LOWER LEFT CAST SECTION**



**THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW.

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

**TOOLS REQUIRED**

- 3mm metric Allen key.

**FITTING INSTRUCTIONS**

- Fit button head bolt through frame insert so head sits in counter-bore.
- Place special nut on exposed end of bolt so it goes into the tapered slot.
- Tighten bolt until the nut just contacts tapered face of plastic frame insert.
- Place the assembly into frame recess in position shown above.
- Tighten bolt so frame insert is held in position firmly (do not over tighten).
- Push fit cap in centre as shown above.
- Regularly check to ensure frame insert remains tight.

- Serrer le boulon jusqu'à ce que l'écrou touche la face conique de l'insert de cadre.
- Placer l'assemblage dans le creux de cadre dans la position ci-dessus.
- Serrer le boulon de façon à ce que l'insert de cadre soit maintenu en position fermement (Ne pas serrer complètement).
- Pousser le capuchon au centre, comme ci dessus.
- Vérifier le serrage de l'insert de cadre de façon régulière.
