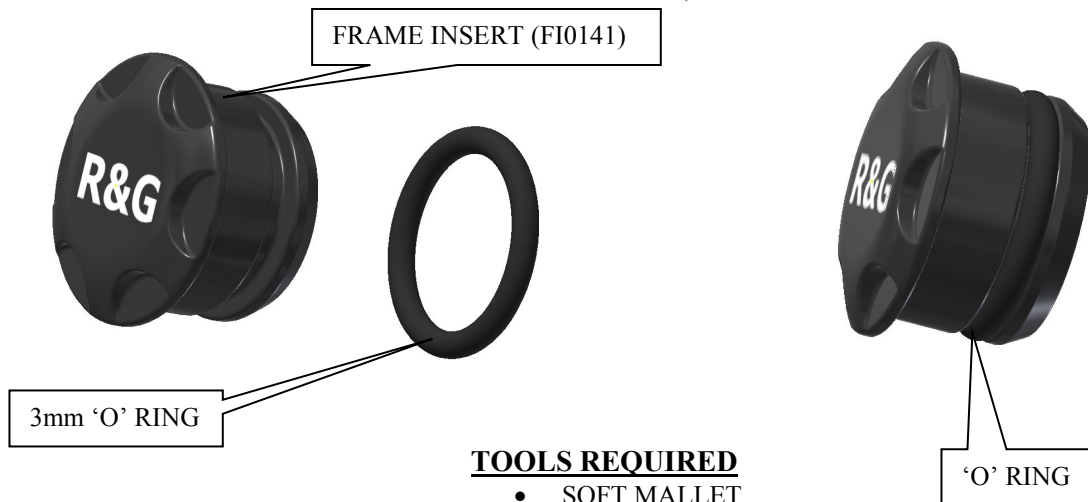

**Left or Right hand side (as you sit on bike)**

- Place the 'O' into the groove of the frame insert as shown above.
- Ensuring the logo is in the correct orientation place the frame insert into the frame recess and gently knock in with a soft mallet or the palm of your hand as shown in the top picture (if very tight a small amount of liquid detergent on the 'O' ring will help).

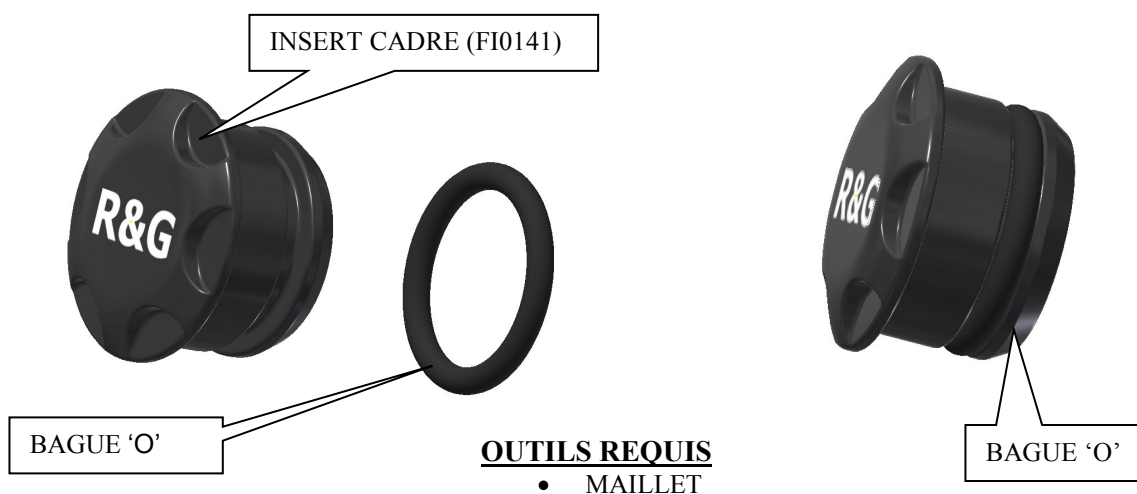
