FITTING INSTRUCTIONS

- Locate the 2 larger frame plugs (FI0096) into the front frame tubes, as seen in picture 1.
- Locate the 2 smaller frame plugs (FI0071) into the rear frame tubes as seen in picture 2.
- Ensuring the logo is in the correct orientation, gently knock in each plug with a soft mallet or the palm of your hand.
