


FITTING INSTRUCTIONS FOR FP0178BK FORK PROTECTORS BMW R1200RS 2015-






THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

Please note that in cases where kits are packed with a plastic tube separating components on the spindle bar (this tube should be discarded).





FITTING INSTRUCTIONS

- Fit one nut and washer on spindle-bar (SB015) (the end with shorter turned down end), engage the nut so the plastic insert of nut is fully engaged.
- Feed spindle-bar with nut and washer through either crash protector (B0442 M8) and through the longer metal spacer (S0907), as shown in the above picture.
- Place this assembly through the front wheel spindle from the right hand side, ensuring the spigot end locates into the spindle.
- Place the remaining shorter metal spacer (S0906) and crash protector over the exposed end of the spindle bar on the left hand side. The metal spacer should locate into original spindle nut.
- Fit washer and nut from kit onto thread and tighten until both nuts are engaged in nylon and equal amounts protrude from either side (please ensure the logo is located at the top of the crash protector). Do not overtighten the nyloc nuts will hold it tight.



INSTRUCTIONS DE MONTAGE

- Installer un écrou et une rondelle sur l'axe (SB015) (l'extrémité avec l'extrémité la plus courter orientée vers le bas), engager l'écrou de façon à ce que l'insert en plastique de l'écrou soit complètement engagé.
- Passer l'axe avec écrou et rondelle à travers l'une des 2 protections (B0442 M8) et à travers l'entretoise en métal (S0907), voir photo ci-dessous .
- Placer l'ensemble à travers l'axe de roue avant depuis la droite, en veillant à ce que le fausset se place dans l'axe.
- Placer l'entretoise en métal restante (S0906) et la protection crash autour de l'extrémité de l'axe du coté gauche de la moto. L'entretoise en métal doit se placer à l'intérieur de l'axe de roue.
- Installer la rondelle et l'écrou du kit sur le filetage puis serrer jusqu'à ce que les 2 écrous soient engagés dans le nylon avec une longueur égale dépassant de chaque coté (assurez vous que le logo soit logé vers le haut de la protection). NE PAS TROP SERRER – Les écrous bloquent suffisamment.
