


Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

ITEM 1 = B0479 with HELICOILS FITTED (LEFT) (x1). ITEM 2 = B0448 with HELICOILS FITTED (RIGHT) (x1). ITEM 3 = M5 x 6mm long GRUB SCREWS (x6).

FITTING INSTRUCTIONS

- Take the crash protector with the internal round (item 1 B0479) and fit over the left side front spindle bolt head and secure using three grub screws.
- Take the crash protector with the internal hexagon (item 2 B0448) and fit over the right side front spindle nut and secure using three grub screws.





