

FITTING INSTRUCTIONS FOR LS0008BK LOCKSTOP SAVERS DUCATI PANIGALE V4, V4S, SPECIALE '18-

FITTING INSTRUCTIONS

- Assemble the bobbins to the mounting plates by pressing them into the slots as shown in picture 1.
- Place a bolt through both mounting plate holes as shown in picture 1 ensuring that the bolt goes through the side with the greater angle as shown in picture 2. Place a spacer on the opposite side of the mounting plate as shown in pictures 2 and 3.
- Remove the 2 bolts arrowed in picture 1.
- Use the M5 bolts to secure the lockstop saver assembly in place as shown in picture 4.
- Repeat for both sides.
- Do not overtighten the bolts, a maximum torque setting of 12Nm is advised for the supplied M5 bolts.
- Regularly check to ensure lockstop saver remains tight.

- Assembler les bobines sur les plaques de fixation en les pressant dans les fentes, voir photo 1.
- Placer un boulon dans les 2 trous de la plaque de fixation, voir photo 1 en veillant à ce que le boulon se place du côté possédant le plus grand angle, voir photo 2. Placer une entretoise du côté oppose de la plaque de fixation, voir photos 2 et 3.
- Enlever les 2 boulons, voir photo 1.
- Utiliser les boulons M5 pour fixer la protection d'arrêt de verrouillage en place, voir photo 4.
- Répéter l'action des 2 côtés.
- Ne pas trop serrer les boulons, nous vous conseiller de serrer à maximum 12Nm les boulons M5 fournis.
- Vérifier le serrage de la protection de façon régulière.

- Die Lenkeranschläge an den Montageplatten anbringen, indem Sie sie in die Öffnungen eindrücken, wie in Abbildung 1 abgebildet.
- Eine Schraube in beide Öffnungen an der Montageplatte einführen wie in Abbildung 1 abgebildet. Bitte darauf achten, dass die Schraube durch die Seite mit dem größeren Winkel geführt wird siehe Abbildung 2. An der gegenüberliegenden Seite der Montageplatte einen Distanzhalter montieren siehe Abbildungen 2 und 3.
- Entfernen Sie die zwei Schrauben, die in Abbildung 1 gekennzeichnet sind.
- Benutzen Sie die M5 Schrauben, um die Lenkeranschlag-Einheit sicher in Position zu befestigen wie in Abbildung 4 abgebildet.
- An beiden Seiten wiederholen.
- Ziehen Sie die Schrauben nicht zu stark an für die mitgelieferten M5 Schrauben ist ein maximales Drehmoment von 12Nm empfohlen.
- Überprüfen Sei regelmäßig, dass die Lenkeranschläge ordnungsgemäß befestigt sind.
