

FITTING INSTRUCTIONS FOR MBP0009BK MIRROR BLANKING PLATE DUCATI 848/1098/1198



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – the rubber washers should be thrown away!

TOOLS REQUIRED

4mm metric Allen key.

FITTING INSTRUCTIONS

- Remove the 4mm allen key bolt from the underside of the mirror mount.
- Pull the mirror from above and this will pop the two bosses out of there mounts.
- Expose the indicator wiring from behind the front subframe and undo the connection. The mirror will now come away.
- Ensure the rubber gasket from the top of the fairing is removed and offer the R&G blanking plates into position. The bosses should fit snugly into the three holes in the fairing.
- With the subframe rubber gasket aligned, place the M5 x 15mm button head bolt through the subframe and into the central boss. This can now be tightened. Do not overtighten as this may cause damage to the fairing.
- Repeat for the opposite side.

Instructions de montage

MBP0009BK Plaque d'obturation de miroir DUCATI 848/1098/1198



La façon dont le kit est emballé ne représente pas nécessairement la façon de le monter sur la moto.

Les parties représentées peuvent parfois être uniquement représentatives (Pour la clarté des explications).

Notez que dans les cas où les kits sont emballés avec des rondelles en caoutchouc, composantes du boulon - les rondelles en caoutchouc doivent être jetées!

Outils requis

• Clef Allen 4mm

Instructions de montage:

- Enlever les 2 boulons avec la clef Allen de 4mm, depuis le dessous du support de rétroviseur.
- Tirer le rétroviseur par le dessus et cela mettra les deux patrons hors de leurs montures.
- Exposer le câblage des clignotants par le derrière du sous cadre avant puis débrancher la connexion. Le rétroviseur va maintenant se détacher.
- S'assurer que le joint en caoutchouc du dessus de carénage soit enlevé puis mettre la Plaque d'obturation de miroir en position. Les patrons doivent bien s'ajuster dans les trois trous dans le carénage.



- Avec le joint en caoutchouc aligné, placer le boulon à tête ronde M5 x 15mm à travers le sous cadre et dans le patron central. Vous pouvez à présent serrer. Ne pas trop serrer non plus, afin de ne pas abîmer le carénage.
- Répétez ces étapes pour l'autre coté.
