



FITTING INSTRUCTIONS FOR MBP0014BK MIRROR BLANKING PLATE
KAWASAKI NINJA 300 '13-, NINJA 250 '13- and NINJA ZX-6R 636 '13-



Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike

THE PARTS SHOWN MAY BE REPRESENTATIVE ONLY (FOR CLARITY OF INSTRUCTIONS ONLY)

Please note that in cases where kits are packed with rubber washers holding the components onto the bolt – *the rubber washers should be thrown away!*

TOOLS REQUIRED

- 4mm A/F Allen key.

FITTING INSTRUCTIONS

- Remove the two bolts that secure the wing mirror in place on the screen.
- Offer the R&G blanking plates into position and fit two M6 x 16mm (or the longer bolts depending on model) countersunk bolts through the blanking plate and into the threaded bosses
- Repeat the above for the opposite side.

KAWASAKI NINJA 300 2013**



La façon dont le kit est emballé ne correspond pas forcément à la façon de monter les pièces sur la moto.

Notez que si les kits sont emballés avec des rondelles en caoutchouc servant à tenir les composants, ces rondelles doivent être jetées.

Outils requis

- Clé Allen 4 mm

Instructions de montage:

- Enlever les 2 boulons qui fixent le miroir lateral en place sur l'écran.
- Poser les obturateurs R&G et passer les 2 boulons à tête fraisée M6 x 16mm à travers la plaque d'obturation et dans les bosses filetées.
- Répéter cette action pour le coté opposé
