FITTING INSTRUCTIONS

- Remove the panel surrounding the instrument cluster (arrowed in Picture 1) by removing the 8x black bolts.
- Remove the OEM mirrors by removing the 4x silver nuts on the inside of the front fairing.
- Place one of the mirror blanking plates over the exposed holes & thread 2 of the bolts through, then tighten the plastic nuts onto the bolts. DO NOT OVERTIGHTEN.
- Repeat for the other side, ensuring the R&G logo is in the correct orientation & refit instrument panel.
