

ITEM 2 = MOULDED LEVER GUARD (NOT INCLUDED IN FITTING KIT) (LG0003).

ITEM 3 = THREADED SPACER (S0856) (x1).

TOOLS REQUIRED

- Set of Allen keys to include 4mm A/F.
 - 19mm A/F Spanner or Socket
- Whatever tools required to remove original bar-end if applicable.

FITTING INSTRUCTIONS

- To fit the Lever Guard (item 2) remove the original bar end.
- Insert and tighten the threaded spacer (item 3) into the bar.
- Place the counter-sunk bolt (item 1) through the Lever Guard.
- Locate the assembly into the threaded spacer and position so when the motorcycle is at full lock in both directions it does not contact any other part of the motorcycle.
- Fully tighten the bolt and check operation.



- Pour monter le Garde levier (article 2), enlever l'extrémité d'origine du guidon.
- Insérer et serrer l'entretoise (article 3) dans le guidon.
- Placer le boulon (article 1) dans le Garde levier
- Placer l'ensemble dans le guidon et en position de façon à ce que le garde ne puis en aucun cas toucher une autre partie de la moto lorsque le guidon est verrouillé au maximum d'un coté ou de l'autre de la moto.
- Serrer complètement le boulon puis vérfier le fonctionnement.
