

ITEM 1 = M6x60mm LONG COUNTER-SUNK BOLT (x1).

ITEM 2 = MOULDED LEVER GUARD (NOT INCLUDED IN FITTING KIT) (LG0003).

ITEM 3 = SPACER (S1048) (x1).

ITEM 4 = THREADED SPACER (M0507) (x1).

TOOLS REQUIRED

- Set of Allen keys to include 4mm A/F.
 - 15mm A/F Spanner or Socket
- Whatever tools required to remove original bar-end if applicable.

FITTING INSTRUCTIONS

- To fit the Lever Guard (item 2) remove the original bar end.
- Insert and tighten the threaded spacer (item 3) into the bar.
- Place the counter-sunk bolt (item 1) through the Lever Guard.
- Locate the assembly into the threaded spacer and position so when the motorcycle is at full lock in both directions it does not contact any other part of the motorcycle.
- Fully tighten the bolt and check operation.



- Pour monter la protection levier (article 2), enlever l'embout de guidon d'origine.
- Insérer et serrer l'entretoise (article 3) dans le guidon.
- Placer le boulon (article 1) dans la protection levier.
- Placer l'ensemble dans le guidon et positionnez-le de façon à ce que, lorsque le guidon est tourné au maximum dans les 2 sens, la protection ne touche pas le carénage.
- Serrer complètement le boulon et vérifier le fonctionnement.
