

FITTING INSTRUCTIONS

- Please Note: To fit the Moulded Lever Guard, you may need to remove the OEM bar ends.
- Place the counter-sunk bolt (Item 2) through the brake lever guard (Item 1), spacer (Item 3) and into the expanding nut (Item 4).
- Thread the tapered nut until it just makes contact with the spacer.
- Locate the entire assembly into the bar and position so when the motorcycle is at full lock in both directions it does not contact any other part of the motorcycle or **restrict throttle use**.
- Using a 4mm Allen tool, tighten the bolt and check operation.


