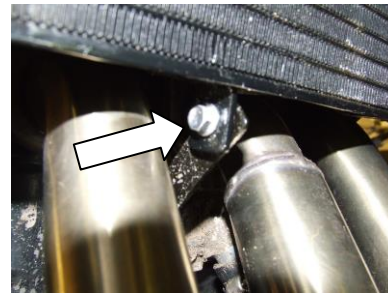
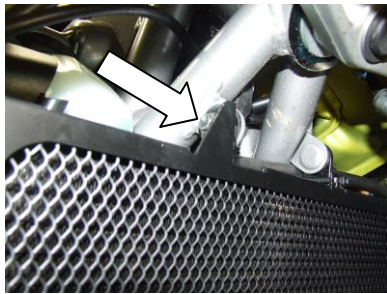




## Fitting Instructions for RAD0187BK/TI Radiator Guard TRIUMPH TIGER 800XCX/XRX 2015-



**In This Kit There Should Be  
1x Radiator Guard (RAD0187)  
1 x Cable/Zip Ties  
4x 100mm Lengths of Foam**



- To fit the radiator guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator.
- Undo and remove lower radiator mounting bolt shown in picture above right.
- Undo and remove upper radiator mounting bolt shown in picture above left.
- Offer the radiator guard into position and using original upper bolt secure the guard into position.
- Using the original lower bolt secure the guard and radiator into position.
- The cable tie goes through the slots at the top of the radiator guard and around the mounting brackets of the radiator as shown above left.
- Tighten all bolts.

**Instructions de montage RAD0187BK/TI protection de radiateur**  
**TRIUMPH TIGER 800XCX/XRX 2015-**



**Ce kit doit contenir:**  
**1x protection de radiateur (RAD0187)**  
**1 x câble de serrage**  
**4x longueurs de 100mm de mousse**



- Coupez des morceaux de mousse de 10 mm environ et placez ceux-ci sur la grille de protection (les mettre entre la grille et le radiateur).
- Enlevez la vis de fixation de radiateur inférieure (voir photo de droite).
- Enlevez la vis de fixation de radiateur supérieure (voir photo de gauche).
- Placez la protection de radiateur sur la moto et fixez la partie supérieure à l'aide de la vis d'origine.
- Fixez la partie inférieure à l'aide de la vis d'origine.
- Le câble en plastique sera a positionner dans le trou supérieur et celui-ci devra entourer les pattes de fixation du radiateur (fixation supérieures).
- Serrez les vis.



## **Montageanleitung für den RAD0187BK/TI Kühlerschutz** **TRIUMPH TIGER 800XCX/XRX 2015-**



**Dieser Kit beinhaltet:**  
**1x Kühlerschutz (RAD0187)**  
**1 x Kabelbinder**  
**4x 100mm Schaumstoffstreifen**



- Um den Kühlerschutz am Motorrad zu montieren, schneiden Sie zuerst die mitgelieferten Schaumstoff-Streifen in 10 mm breiten Streifen und kleben Sie diese auf der Rückseite des Kühlerschutzrahmens, so dass sie zwischen dem Kühlerschutz und dem Kühler angebracht sind.
- Lösen und entfernen Sie die untere Montageschraube für den Kühler (siehe Abbildungen oben rechts).
- Lösen und entfernen Sie die obere Montageschraube für den Kühler (siehe Abbildungen oben links).
- Den Kühlerschutz in Position bringen und mit der (oberen) Originalschraube sichern.
- Fixieren Sie den Kühlerschutz und den Kühler mit der Originalschraube für unten.
- Führen Sie den Kabelbinder durch die Schlitze oben auf dem Kühlerschutz, dann um die oberen Kühlerschutzhalter, wie oben links abgebildet.
- Ziehen Sie alle Schrauben fest.
