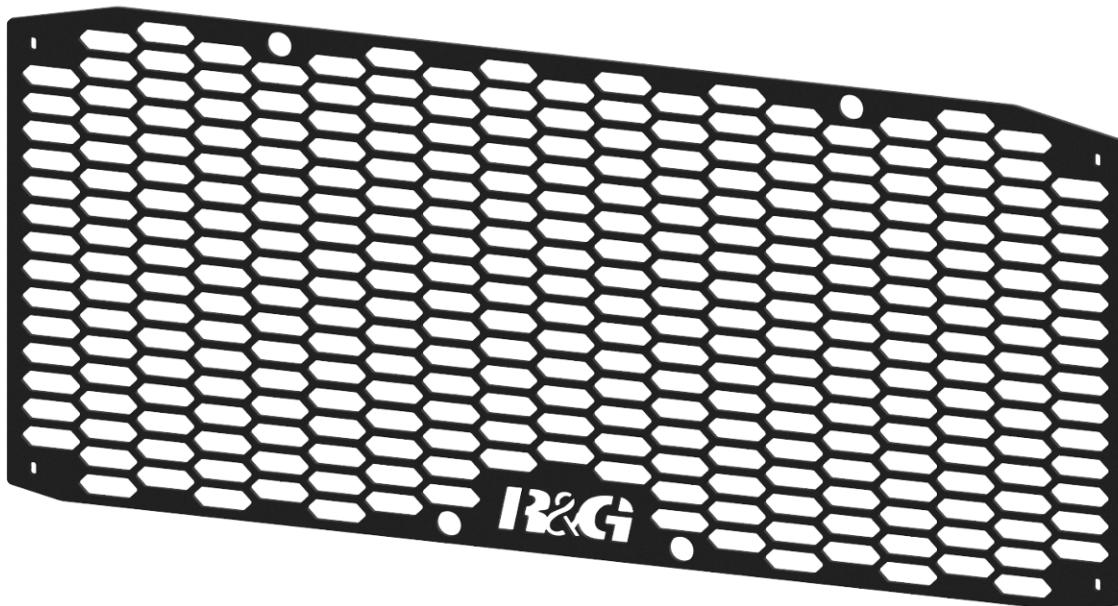

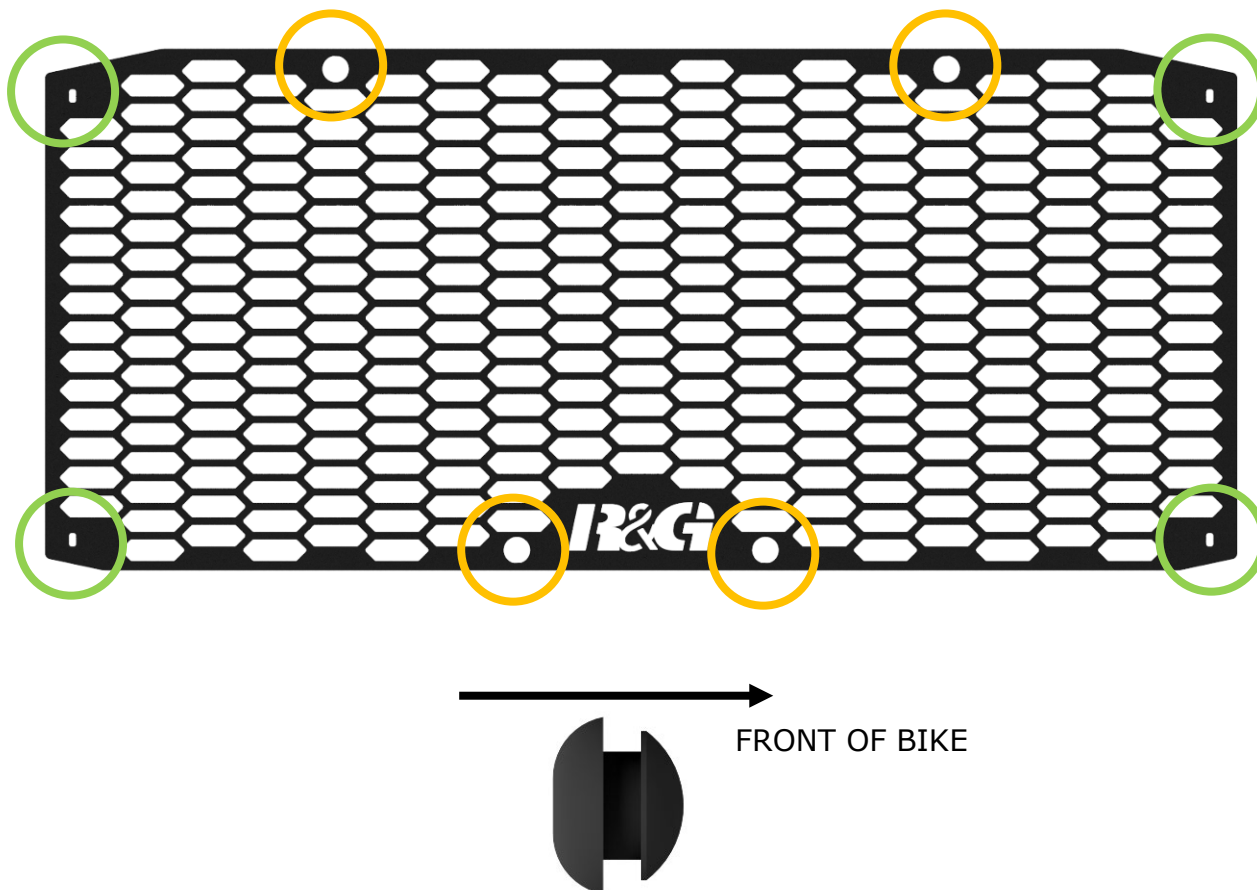

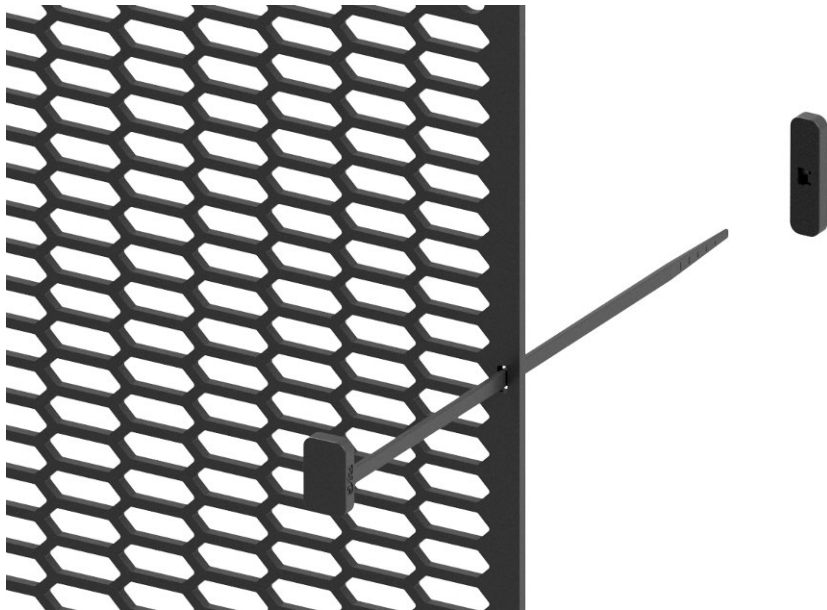

FITTING INSTRUCTIONS

- Insert the 4x rubber grommets into the radiator guard in the holes circled in yellow (as shown above) if they do not come already installed.
- Slide the R&G Radiator Guard into position.
- Secure in place using 4 x supplied R&G cable ties as shown in the Fitting Picture above, the cable ties should go through the 4X holes circled in green in the assembly diagram. The locking part of the cable tie needs to be secured from behind the radiator.

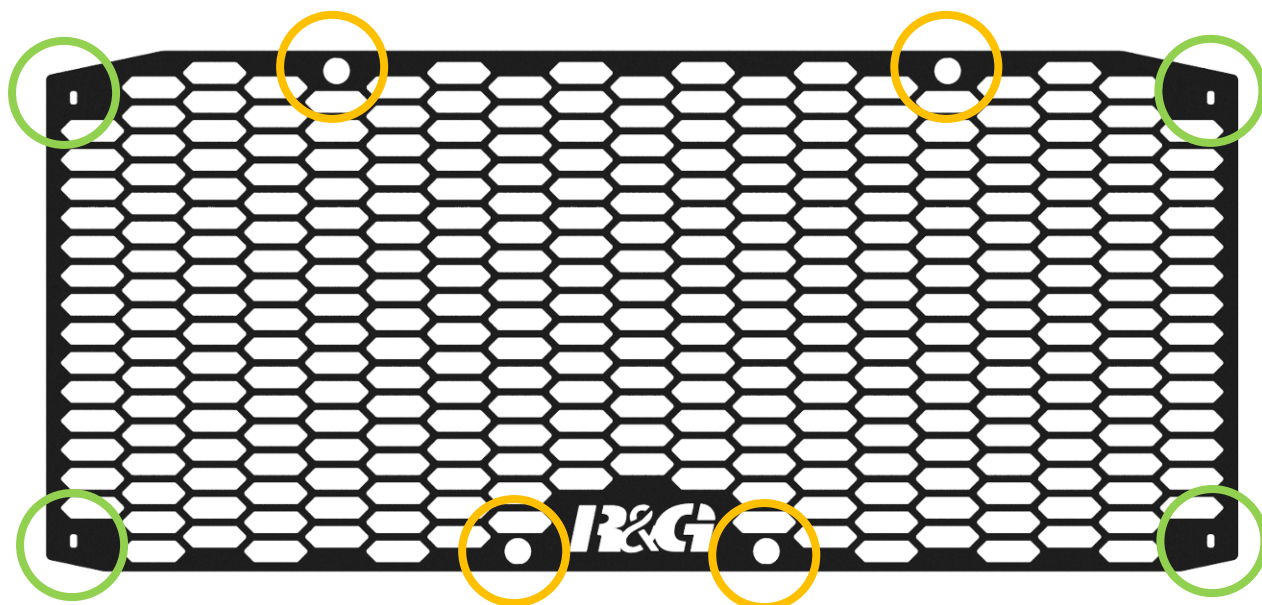

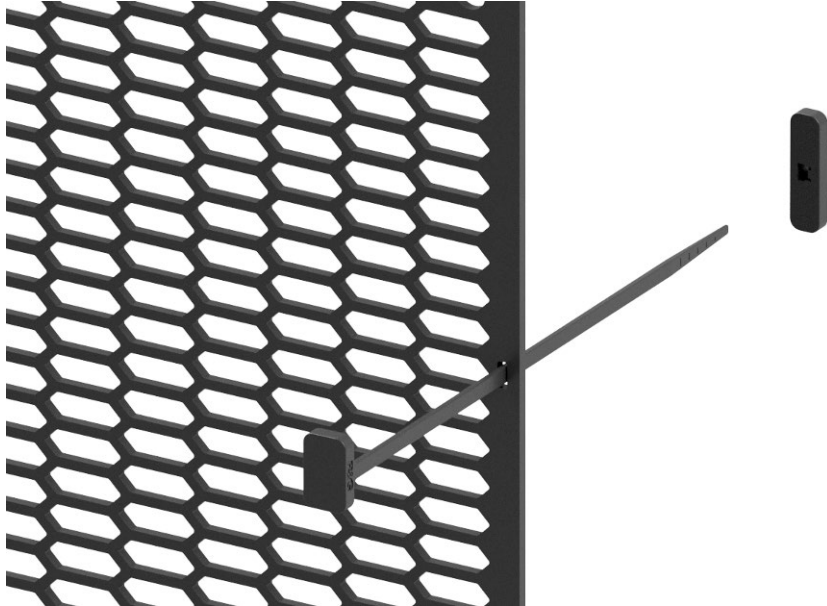
