

Fitting Instructions for SRG0010SS Radiator Guard APRILIA CAPONORD 1200 2013



In This Kit There Should Be
1x Radiator Guard (SSRAD0010).
2x 100mm Lengths of self-adhesive Foam.
4x Cable Ties

TOOLS REQUIRED

• Socket set to include 8 and 10mm sockets & wrench.

FITTING INSTRUCTIONS

- To fit the radiator guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the radiator guard frame, so that they sit between the radiator guard and the radiator (also between the guard and the oil cooler).
- Remove the nut arrowed in picture 1.
- Offer the radiator guard into position as shown in top picture.
- Secure the bottom mounting bracket as shown in picture 1 using the original nut.
- Use the four cable ties to secure the radiator into position as shown in pictures 2, 3, 4 and 5.



Instructions de montage:

- Couper la mousse en bandeaux de 10mm puis collez ces bandeaux au bas du support de protection radiateur, de façon à ce que ces bandeaux se situent entre la protection radiateur et le radiateur (entre la protection et le refroidisseur d'huile également).
- Enlever l'écrou (Photo 1).
- Mettre la grille R&G en position (photo du haut).
- Fixer le support de fixation du bas (Photo 1) en utilisant l'écrou d'origine.
- Utiliser les 4 colliers pour fixer le radiateur en position (Photos 2, 3, 4 et 5).



MONTAGEANLEITUNG

- Um den Kühlerschutz am Motorrad zu montieren, schneiden Sie zuerst die mitgelieferten Schaumstoff-Streifen in 10 mm breite Streifen und kleben Sie diese auf der Rückseite des Kühlerschutzrahmens, so dass sie zwischen dem Kühlerschutz und dem Kühler angebracht sind (auch zwischen dem Kühlerschutz und dem Ölkühler).
- Entfernen Sie die Mutter, die in Abbildung 1 abgebildet ist.
- Den Kühlerschutz in Position anbringen, wie in der oberen Abbildung abgebildet.
- Die untere Montagehalterung mit der Originalmutter befestigen siehe Abbildung 1.
- Verwenden Sie die vier Kabelbinder, um den Kühlerschutz in Position zu befestigen siehe Abbildungen 2, 3, 4 und 5.
