



## **FITTING INSTRUCTIONS FOR SS0018BK SPINDLE-SLIDERS DUCATI 1098 1198, StreetFighter**



**LEFT-HAND SIDE**



**RIGHT-HAND SIDE**

**Please note that the way the kit is packed does not necessarily represent the way of mounting to the bike**

- PASS SPINDLE BAR THROUGH REAR SPINDLE
- PLACE BOBBINS AND ALUMINIUM SPACERS ON EITHER END OF SPINDLE BAR, (PLEASE NOTE ON CERTAIN MODELS ON THE LEFT HAND SIDE THE SPINDLE RECESS IS SMALLER SO THE ALTERNATIVE SPACER SUPPLIED SHOULD BE USED) LOCATING THEM INTO EACH END OF THE SPINDLE (NOTE SHORTER BOBBIN FITS LEFT HAND SIDE OF BIKE AS SHOWN ABOVE)
- PLACE WASHER AND NUT OVER EACH END OF SPINDLE BAR AND TIGHTEN - DO NOT OVERTIGHTEN – THE NYLOC NUTS WILL HOLD IT TIGHT

Returns must be pre-authorized (if not pre-authorized the return will be rejected). Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor. Goods must be in resellable condition, in the opinion of R&G Racing. All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase). The customer must pay any and all carriage charges. No returns of discontinued products, unless within 14 days of purchase. This policy does not affect your statutory rights and does not refer to faulty goods.

### Conseil de montage:

- 1- Mettre la barre R&G à travers l'axe arrière.
- 2- Mettre les entretoises en aluminium et les tampons sur l'axe R&G:  
(la plus petite entretoise se place côté couronne)
- 3- Mettre une rondelle et un écrou pour chaque côté, puis serrer les écrous.
- 4- Ne pas trop serrer les écrous, en effet leur fonction autobloquante gardera l'ensemble bien en place
