FITTING INSTRUCTIONS FOR XT660 X SWINGARM PROTECTORS (CODE SP0008BK)



- Place spacers into appropriate holes each side of rear wheel spindle
- Push bar (on pre-2009 models use the longer spindle bar), thin end first, through the hollow spindle from chain side (please note on 2009 models you will need to use the shorter spindle bar)
- Place black bobbins on each end of bar. The bobbin with the larger hole fits on the chain side
- Fit washers and nuts loosely onto each end of the bar
- With a socket on either end, tighten until the assembly locks into place
- Do not overtighten the nyloc nuts will hold it tight.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorised (if not pre-authorised the return will be rejected)

Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary). Otherwise to be returned to original vendor.

Goods must be in re-sellable condition, in the opinion of R&G Racing.

All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase)

The customer must pay any and all carriage charges.

No returns of discontinued products, unless within 14 days of purchase.
