


# Fitting Instructions for SCG0005SS Stainless Steel Oil Cooler Guard YAMAHA YZF-R1 '15-

# GENERAL TORQUE SETTINGS M4 BOLT = 8Nm

M4 BOLT = 8Nm M5 BOLT = 12Nm M6 BOLT = 15Nm M8 BOLT = 20Nm M10 BOLT = 40Nm

M12 NYLOC NUT = 40Nm

# **TOOLS REQUIRED**

• 4 & 5mm Allen key or socket bits.



## FITTING INSTRUCTIONS

- To fit the oil cooler guard to the bike cut the foam strip provided into 10mm wide pieces and stick them to the back of the oil cooler guard frame, so that they sit between the oil cooler guard and the oil cooler radiator.
- Remove the fairings from the bike. To do this on the left side of the bike, remove the four quick release fixtures on the fairing, as arrowed in picture 1. On the inside of the fairing, there are four push rivets to be removed, as shown in pictures 2 & 3, before the panel can gently slide forward and be removed from the bike.
- Repeat this process to remove the fairing from the right side of the bike. *Please note there are only three push rivets on the right.*
- Remove the two bolts that secure the oil cooler cowling in place, as shown in picture 4.
- Remove the cowling by lifting upwards to clear the two location tabs on the oil cooler, as shown in picture 5.
- Remove the OEM oil cooler guard by lifting upwards, releasing the two mounting tabs at the top
  from the slots on the guard.
- Take the R&G Oil Cooler Guard and fit in the same way as the OEM guard was removed, as shown in picture 5 & 6.
- Re-fit the oil cooler cowling and tighten the two bolts, securing the oil cooler guard in place..
- Re-fit the fairings to both sides of the bike.



### **INSTRUCTIONS DE MONTAGE**

- Pour monter la grille de protection radiateur sur la moto, couper la mousse fournie en bandeaux de 10mm de large et collez les au bas du cadre de grille de protection refroidisseur d'huile, de façon à ce qu'ils se placent entre la grille de protection refroidisseur d'huile et le refroidisseur d'huile.
- Enlever les carénages de la moto. Du coté gauche de la moto, enlever les 4 fixations sur le carénage, voir photo 1. A l'intérieur du carénage, il y a 4 rivets à enlever, voir photos 2 & 3, avant de glisser le carénage vers l'avant pour l'enlever de la moto.
- Répéter le process pour enlever le carénage du coté droit de la moto. *Note : Il y a seulement 3 rivets poussoirs du coté droit*.
- Enlever les 2 boulons qui fixent le capot de refroidisseur d'huile en place, voir photo 4.
- Enlever le capot en le glissant vers le haut pour apercevoir les 2 onglets sur le refroidisseur d'huile, voir photo 5.
- Enlever la grille de protection do'rigine en la glissant vers le haut, by lifting upwards, libérant les deux onglets de fixation sur le haut des fentes sur la protection.
- Prendre la grille de protection R&G et montez la de la même façon que la grille d'origine a été enlevée, voir photo 5 & 6.
- Remettre le capot de refroidisseur d'huile puis serrer les 2 boulons.
- Remettre les carénages des 2 cotés de la moto.
