



**FITTING INSTRUCTIONS FOR R&G FORK PROTECTORS
KAWASAKI VERSYS 650 '06 (part code FP0059BK)
Please read all instructions before commencing fitting**

- Fit one nut and washer to spindle bar until the thread tightens on plastic of loc nut
- Push through either bobbin
- Position wider spacer from kit up to flat face of bobbin.
- Push assembly through front wheel spindle from right hand side as you sit on bike.
- Place other spacer on spindle bar protruding from other side of spindle so counter-bore goes over thread on front wheel spindle.
- Put other bobbin on spindle bar with flat face against spacer
- Fit washer and nut counter-bore in bobbin and tighten until it locks. **DO NOT OVERTIGHTEN.** The nyloc nuts will hold it tight.

Other than identified above and subject to R & G not limiting its liability for causing death and personal injury, it shall not be liable for indirect or consequential loss and otherwise its liability shall be limited to the amounts paid by the Buyer for the Products or the fitting or service concerned.

These terms do not affect the Buyer's statutory rights.

R&G RACING RETURNS POLICY (NON-FAULTY GOODS)

Returns must be pre-authorized (if not pre-authorized the return will be rejected)

Goods may only be returned direct to us if they were purchased direct from us (customer must prove if necessary).

Otherwise to be returned to original vendor.

Goods must be in re-sellable condition, in the opinion of R&G Racing

All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase)

The customer must pay any and all carriage charges

No returns of discontinued products, unless within 14 days of purchase

This policy does not affect your statutory rights and does not refer to faulty goods
