


# FITTING INSTRUCTIONS FOR FP0183BK FORK PROTECTORS NORTON COMMANDO 961 SE- SPORT MKI-MKII '09-



## THIS KIT CONTAINS THE ITEMS PICTURED AND LABELLED BELOW. DO NOT PROCEED UNTIL YOU ARE SURE ALL PARTS ARE PRESENT.

ITEM  $1 = 2 \times M8$  nyloc nuts

ITEM  $2 = 2 \times M8$  washers

ITEM  $3 = 2 \times R\&G \text{ Crash Bobbins (B0510M BK)}$ 

ITEM 4 = 1 x L/H Spacer 15mm long (S0941 BK)

ITEM  $5 = 1 \times \text{Spindle bar } 325 \text{mm long } (\text{SB}120)$ 

ITEM  $6 = 1 \times R/H$  Spacer 18mm long (S0942 BK)

#### **TOOLS REQUIRED**

- Socket set to include 2x 13mm sockets.
  - Wrenches

## FITTING INSTRUCTIONS

- Starting from the L/H, as you sit on the bike, fit L/H spacer S0941 (Item 4) over the hexagon shaped OEM spindle head on the left hand side of the front spindle.
- Fit one M8 nyloc nut (Item 1) and M8 washer (Item 2) onto the end with shorter thread of the Spindle bar SB120 (Item 5) from the kit. Engage the nut so the nylon insert of the nut is fully engaged.
- Feed the spindle bar (SB120) with nut and washer through either R&G bobbin B0510 (Item 3) and through the spacer just fitted
- Place the remaining spacer (S0942 Item 6) over the exposed right hand end of spindle bar so the spacer fits
  inside the round shaped recess on the front spindle. Then slide the remaining R&G bobbin B0510 (Item 3)
  onto the spindle bar.
- Fit the remaining M8 washer (Item 2) and nyloc nut (Item 1) from the kit onto the thread and tighten until both nuts are engaged in nylon.
- Do not overtighten the nyloc nuts will hold it tight



## **NOTICE DE MONTAGE**

- En partant du coté gauche, lorsque vous êtes assis sur la moto, insérer l'entretoise coté gauche S0941 (Article 4) sur la tête d'axe d'origine sur coté gauche de l'axe d'origine.
- Insérer un écrou M8 (Article 1) et une rondelle M8 (Article 2) sur l'extrémité au filetage le plus court de l'axe SB120 (Article 5) du kit. Engager l'écrou de façon à ce que l'insert en nylon de l'écrou soit complètement engagé.
- Passer l'axe (SB120) avec écrou et rondelle à travers l'une des bobines R&G B0510 (Article 3) et dans l'entretoise tout juste insérée.
- Placer l'entretoise restante (S0942 Article 6) sur l'extrémité droite de l'axe de façon à ce que l'entretoise se place dans le creux rond de l'axe avant. Puis, glisser le bobine R&G restante B0510 (Article 3) sur l'axe.
- Insérer la rondelle M8 (Article 2) et l'écrou (Article 1) du kit sur le filetage puis serrer jusqu'à ce que les 2 écrous soient engagés dans le nylon.
- NE PAS TROP SERRER Les écrous bloquent suffisamment.
