Database Subscription License and Terms of Use

This is a legal agreement between you (Licensee), and Managed Care On-Line, Inc. (MCOL). If you do not agree to comply fully with the terms of this agreement, do not register yourself with MCOL for this online database subscription, and immediately cancel your subscription for a full refund, indicating you do not wish to enter into this Licensing Agreement.

License

1. Database and Title. This subscription license agreement is for online access to the MCOL database entitled HealthQuest Online Directory Database (Database). MCOL holds full and complete title to the Database, regardless of the media or form on or in which the original content may exist. This license does not constitute a sale of the Database, only a non-exclusive grant of license.

2. License Grant. The Licensee is permitted by MCOL as a single user to login online with credentials registered with MCOL and access the Database as long as Licensee's Database Subscription is in good standing with MCOL. Licensee agrees to not provide Licensee access to the Database, or provide data exported from the Database to any third party, unless Licensee has entered into a Site License agreement providing specific terms of access to additional parties.

3. Copyright. This Database is protected by United States copyright laws and international treaty provisions. You must treat Database like any other copyrighted material.

4. Assignment and Other Restrictions. You may not rent or lease Database Access or Database exported data to third parties. You may permanently transfer and assign this License to a third party for the duration of the Subscription, provided the party agrees to the terms of this Agreement, and you retain Access to Database.

5. Limited Warranty. MCOL warrants Database will generally be available for online access and as represented in MCOL Database product information provided in MCOL websites. Licensee acknowledges that online access may be temporarily unavailable at a given point in time due to various circumstances. Any implied warranties are limited to five (5) days, except when duration is unlimited by state law of Licensee.

6. Licensee Remedies. Licensee may obtain a full refund if Subscription is cancelled within five (5) days of initial access granted by MCOL. Licensee may request a pro-rata refund for annual subscription fees paid in the event online access is discontinued by MCOL.
