### I. OVERVIEW

The Medicare Managed Care Directory 2022, compiled by MCOL's HealthQuest Publishers, offers a unique resource for Medicare Advantage health plan and Medicare Prescription Drug Plan stakeholders and others monitoring Medicare managed care. Included are Organizational Directories of Medicare health plans and Medicare PDPs. Key staff are listed for each organization. Also included are Executive Profiles of CMS Medicare executives and staff, as well as indexes for referencing individuals and organizations included in this Directory.

The scope of the Medicare organizations listed in this Directory includes Medicare contracted Medicare Advantage and related health plans and Medicare contracted Prescription Drug Plans (PDPs.). Organizations with multiple Medicare contracts being served from the same location are merged into one listing in this Directory. Thus the number of organizations listed in the Directory is less than the total number of Medicare contracts being served; however each Medicare contract number and applicable summary information for each contract is included in the listing for organizations serving more than one contract from the same location.

712 organizations and 4,695 employees are included in the Directory listings. Please note listings for each organization are designed to all be provided on the same page. Thus some pages only contain one organization, while other pages may contain two. Some employees are listed in multiple organizations, based upon their simultaneous assumption of responsibilities for applicable organizations involving their parent or affiliated organizations. Also please note employee phone numbers are only listed when direct lines different from the main company phone number are available.

The Medicare Health Plan Directory includes summary information by state for 651 Medicare health plans, as well as a listing of 4,472 key relevant health plan staff. Health plan staff with no Medicare relevance are not listed, such as with positions specific to Medicaid or commercial products.

### Profile:

Ms. Tia N. Butler was appointed as the Chief Human Capital Officer for the Centers for Medicare and Medicaid Services (CMS) in April 2020. In this role, Ms. Butler is responsible for the recruitment, development and retention of CMS' most valuable resources, its people, who operate daily in achieving the CMS objective: to improve the nation's health and quality of life. Prior to joining CMS, Ms. Butler served as the Deputy Associate Director for Retirement Services (DC) at the U.S. Office of Personnel Management. There, Ms. Butler was responsible for directing the adjudication of specialty retirement claims, administering the annual health benefits Open Season for annuitants, developing retirement policy and legislation, and leading programs to educate benefits officers government-wide about retirement.

Ms. Butler was initially appointed to the Senior Executive Service (SES) as the Executive Director of the Corporate Senior Executive Management Office at the Department of Veterans Affairs (VA). She served as the principal executive advisor to the VA Chief of Staff and Assistant Secretary, Human Resources & Administration regarding enterprise executive management and was appointed by the VA to the White House Advisory Group on SES Reform.

Ms. Butler began her career in public service with the Department of the Navy (DON) as the Communications Director for Civilian Human Resources. She then served as the Staff Director to the Deputy Assistant Secretary of the Navy, Civilian Human Resources and later, the Director of the Executive Management Program Office (EMPO). In EMPO, Ms. Butler focused her efforts on executive succession planning, expanding leadership and executive development opportunities, and initiating the Bridging the Gap Leadership Development Program as the DON's first centralized pipeline development program. Ms. Butler has also worked as a Human Capital and Management Consultant in both the management consulting and public relations/advertising fields. Ms. Butler holds a BA in Anthropology from the University of Virginia and a MA in Education and Human Development, with a concentration in Human & Organizational Learning from the George Washington University.
