PRODUCT DESCRIPTION

It seals and protects against dirt, grime, salt and oil damage while enhancing natural color and shine. This inorganic/organic hybrid Nano-Lithium® treatment creates a breathable, protective clear micro-film that is abrasion resistant and will not flake or peel. Pentra-Guard® (EXT) cures quickly and provides a hard, glossy, wet look finish to any exterior cementitious or inorganic stone surface. This low odor, non-yellowing, lithium-based solution is VOC compliant and easy to apply.

USES

Stamped Concrete, Parking Garages, Fire Stations, Walls or Vertical Surfaces, Sidewalks, Driveways, Decks, Loading Docks, Stadiums, Storage, Foyers, Pedestrian Walkways, Monuments, Cast-in-Place Concrete, Pavers, Bricks, Precast Brick, Natural Stones, Stone Veneers, Decorative Concrete, Colored Concrete, Exposed Aggregate, etc.

APPLICATION

Apply only when temperatures will be above 40°F (4°C) for at least 2 hours following application.

Clean surface to remove any dirt, laitance, curing compounds or coatings that may prevent Pentra-Guard® (EXT) from penetrating the surface. Do not use citrus or acidic cleaners. If acidic or d-limonene cleaners have been used, neutralize the surface using an alkaline cleaner (TSP, Tide laundry detergent, etc.).

Mix well before use.

On rough surfaces, use a low-pressure sprayer to apply Pentra-Guard® (EXT) evenly on the surface and spread out any puddles with a soft bristle broom. Do not over-work material into the surface- spread it and leave it. Allow each application to dry at least 30-60 minutes between coats or before allowing foot traffic.

On smooth surfaces, do not overapply. Very thin coats are best. Apply Pentra-Guard® (EXT) using a microfiber pad that has been pre-dampened with the product. Using a low pressure sprayer, spray lightly and then spread material thinly and evenly using a microfiber pad. For best results, use joint lines as starting and stopping points. Do not over-work material into the surface- spread it and leave it. Allow each application to dry at least 30-60 minutes between coats or before allowing foot traffic.

The surface is ready for use when dry.

*Before application, always do a small test sample in a less-visible area to be sure there are no variables or contaminants in the substrate that may be incompatible with this product.

ESTIMATED COVERAGE

Machine-troweled: 800-1000 ft² (19.6-24.5 m² per liter) Broom-finished: 300-500 ft² (7.4-12.3 m² per liter)

*Coverage rate will vary with concrete porosity and environmental conditions.

CLEAN UP

Use soap and water to clean tools and equipment. Although Pentra-Guard® (EXT) is non-toxic and environmentally safe, it is alkaline. Use up or dry out extra material and dispose of ac-cording to local regulations. Do not pour into sewer systems or storm drains.

MAINTENANCE

Clean with Pentra-Clean™ (CR) or neutral pH cleaners and reapply Pentra-Guard® (EXT) as needed. Consult a Convergent Concrete Representative for further information.
